2. Committee reports:

Treasurer: Tom presented his annual report from January 1 to December 31, 2002. Our balance is \$23,088.41. All dues deducted at source payments for 2002 have been received and one payment due to National Office is outstanding. Payments from National office for cheques sent to them are outstanding. Preliminary figures are 105 members and 62 spouses which will give us a grand total of 933 members and 497 spouses/partners for an over all total of 1430. Bernie said John Challender had forwarded a letter from SCAN stating that they were pleased to receive the information about the FSNA provided by John at these gatherings and will look forward to more presentations in the future.

Media: John will have the pictures from the General meeting developed. He also noted that, for the first time, Shaw had aired the notice of the general meeting on TV.

Welfare: Halle said she had nothing to report.

Programs: Barb said she and Halle would be away for the next General meeting but that she will make the arrangements for the luncheon in March. Velda has agreed to collect the lunch money and Rick will sell the 50?50 tickets. Barb also said she would book the general meetings for 200% so we will be assured of our dates. They will be held on March 10, June 9, September 8 and December 8, 2004.

Newsletter: Ron surmised he would have to adjust the number of papers printed because of all the new members. Tom will give him the numbers.
