Committee Reports:

Treasurer:

Tom reported a closing balance to February 28, 2006 of \$27,041.17. Interest earned to December 31, 2005 was reinvested and added to December 31 investment total. There is still no resolution to the DDS payments owing since the first quarter of 2002 and the DDS cheque for February is outstanding. Tom moved the acceptance of his report, seconded by Bill. Membership:

Reminders were sent to 75 members who have not yet renewed. Dues have been received from a number of these and a number have told him they have changed to DDS. DDS printouts have not been available for nearly a year. Tom moved the acceptance of his report, seconded by Barb. Carried.

Media:

John said that all the posters have been hand delivered and an announcement of the general meeting will be on CH News.

Welfare:

Halle has sent out several cards and has several more to send.

Programs:

Barb said that everything was arranged for the general meeting tomorrow. She has booked for 174 for the meal and has also book the projector for John's presentation.

Webmaster:

Steve said that Sidney was not yet on the web site but they would be discussing their participation at their next meeting. With regard to the membership, he wants to find out if he can go into the new program and make deletions. When the time comes that their membership lists agree, he will take over the Membership from Tom.

Newsletter:

Kevin said he had missed an article for which he apologized. He also told us that he had some complaints regarding jokes in the letter. Kevin and his wife stuffed the envelopes as Quest was closed until March 1. Ian thanked them on our behalf.

Health Benefits:

There was an attempt to have the delegations to the Triennial Convention reduced but no agreement was reached. It will be discussed again at the Convention.
